

# SECTION 77, SCHOOL STANDARDS AND FRAMEWORK ACT 1998

## DISPOSAL AND CHANGE OF USE OF PLAYING FIELD LAND AT ARK SWIFT PRIMARY ACADEMY, AUSTRALIA ROAD, WHITE CITY ESTATE, LONDON W12 7PT

Notice is hereby given that the London Borough of Hammersmith and Fulham (LBHF) and Ark Schools intends to make an Application under Section 77 of the School Standards and Framework Act 1998 (SSFA) to the Secretary of State for Education, for the disposal and change of use of land classified as playing field land at Ark Swift Primary Academy, Australia Road, White City Estate, London W12 7PT.

### Context

EdCity is a proposed new education and social hub in White City. The project proposes to redevelop the Ark Swift Primary Academy site to create a new school building, new Harmony Neighbourhood Nursery and new Adult Community Education Centre, along with new youth facilities, homes, offices and a ground floor restaurant/café. It is a non-profit project being brought forward by the charity Ark and LBHF.

As part of the plans, Ark Swift's current sports and play facilities, which are no longer fit for purpose, will be significantly improved. The plans include:

- The creation of a new outdoor, landscaped open playspace, featuring a running track and a high quality surface and multi-use play areas.
- Removal of the unusable grass area within the existing playspace.
- Adjacent youth facilities that are being built as part of the EdCity project and will provide new, upgraded facilities for Ark Swift's students. They will have use of a rooftop Multi-Use Games Area (MUGA) during the school day and for after-school clubs and activities. They will also have scheduled daytime access to the four-court indoor sports hall.

### The Section 77 application and consultation

As the project involves changing land classified as playing field land, as defined in the SSFA, LBHF and Ark Schools is required to obtain consent from the Department of Education (DfE). This is separate to the planning application approval.

Ark Schools and LBHF are required to consult with the local community and other interested parties in advance of submitting an application to the DfE.

### This formal phase of consultation will take place between 7 February 2019 and 22 March 2019.

This consultation relates solely to the land classified under the SSFA as playing field land that will be redeveloped as part of this project. This affected area is shown on technical plans available on the project website, [www.edcity.org.uk](http://www.edcity.org.uk).

LBHF and Ark Schools will be holding a joint public drop-in session on **5 March 2019** (between 4.30pm and 6.30pm) at Ark Swift Primary Academy, Australia Road, London, W12 7PT. Members of the project team will attend to provide further information and answer any questions.
